MASS CASULATY INCIDENT



On Sunday October 25th at approximately 12:00pm, the Bonita Springs Fire District responded to the following medical/motor vehicle emergency call at the Old 41 Restaurant.

"A car came through the front and it just kept coming," said Dennis Crimboll. "Tables were flying and people were flying, there was glass. The car went all the way to the back of the restaurant."

Deputy Chief Richard Scott *paints a picture* of the 9-1-1 call, the hectic scene and the thought process of the first officer who arrives. Taking into account that the restaurant is "in-season" and has a capacity of nearly 100 people, the amount of patients could have been much more than the first responders on scene. For this reason, this emergency call is classified as a MCI call, or Mass Casualty Incident. BSFD is trained for such circumstances and are to able assess and mitigate potential risks. What are the hazardous conditions? Is there gas, natural gas, or propane





hazards? Is there any structural damage, electrical hazards, etc.? How many patients are involved? Even with all of these variables, a triage area was quickly set up for the patients and a staging area for the ambulance to transport patients to the hospital. The teamwork of the corresponding first responders was remarkable and out of the 20 patients, only 5 were transported to the hospital for further care. For full story, <u>click here</u>

A smoke alarm is only as reliable as its battery. The Bonita Springs Fire Control and Rescue District would like to remind you to change the battery in the smoke alarm twice per year. When you change your clocks, change your smoke alarm battery.

Install smoke alarms on every level of your home, inside each bedroom and outside each sleeping area. Interconnect all smoke alarms throughout the home. When one sounds, they all sound. Did you know that smoke alarms expire after 10 years? Check the date on the back of the alarm to ensure the alarm has not expired. Click here to learn more.

If you are a Bonita Springs resident and a family in need, you will need to register for toys, applications are now available. This year's registration days are November 30 -

December 2 between the hours of 9:00AM-12:00PM at Bonita Springs Fire Station #4, 27701 Bonita Grande Dr. Please remember to being with you these four items: (1) Your completed application; (2) a current driver's license or other photo ID; (3) proof of Bonita Springs residency (this may be satisfied by the address on your identification; other proof of residency may be a utility bill, lease, etc.); and (4) birth certificates or court order documentation for any children you are requesting toys for (ages 2-12 only).

The toys will be distributed December 14 - 16, by appointment only. Families who have already signed up for the gifts/assistance at another location are not permitted to apply with the Fire District.
