#### ***Chief Greg DeWitt***

Chief DeWitt gave the Chief's Report:

- All 11 hired recruits passed their physicals and background checks. They will begin their six-week orientation on April 27, 2026, and should be on shift by mid-June.
- Business After Hours is April 23, 2026, at PLC Closets.
- The INCredible Awards are on May 12, 2026, from 11:30 am to 1:00 pm at the Hyatt Regency Coconut Point.
- The Chamber golf tournament is May 29, 2026, from 8:30 am to 3:00 pm at the Tiburon Golf Club.
- 10 firefighters are attending FDIC, beginning April 19 through April 25, 2026.
- E27 is in Fort Myers and is almost complete.
- The High Water/Brush Truck is delayed due to delays at International Cabs.
- One of the UTV's is here and will be housed at Station 21, and the other will be here the week of April 20<sup>th</sup> and will be housed at Station 26.
- Burn ban is still in effect for Lee, Collier, Glades, and Hendry counties.
- The Florida Fire Chiefs' Association held its meeting at the district.
- There will be several special legislative sessions over the upcoming months, focusing on redistricting, tax reform, and the budget.
- Lee County Sheriff's Office is housing one of its drones at Station 21.
